COUNSELING CENTER RECEIVES NATIONAL "BEST PRACTICE" AWARDS

The Counseling Center was honored recently at the annual meeting of the Mental Health Corporations of America (MHCA) with two "Best Practice" Awards for Customer Satisfaction in the areas of Case Management Services and Employment Services. Best Practice Awards are distributed annually by Mental Health Corporations of America (MHCA) to those organizations who use the MHCA Customer Satisfaction Survey tools and whose reported results are subsequently determined to be the best in the nation among participating organizations providing that particular service. The Case Management Award recognizes the efforts of staff who work with both adults with severe mental illness and children with significant emotional disturbance, as well as in the Counseling Center's Home-Based Intervention program. This is the third year in a row that the Counseling Center has received the award for Case Management services.
